### SIA "FEDEMAC EVENTS" PRIVACY POLICY

The purpose of the privacy policy (hereinafter referred to as the "Policy") of SIA "FEDEMAC EVENTS" (hereinafter referred to as "FEDEMAC EVENTS") is to provide you (the data subject) with information about the legal and factual circumstances of the processing of your personal data, including the purpose, scope, and protection of personal data processing, as well as other relevant information.

Please note that this Policy may be amended, supplemented, or updated. Any changes will be communicated to you by posting the updated information on our website.

We respect your privacy, and the security of your personal data is our priority. We use appropriate organizational and technical means to ensure permanent security of your personal data and compliance of data processing with the requirements of data protection laws and regulations, as well as our internal rules. However, please be aware that the transmission of personal data in the Internet environment cannot be recognized as safe. Therefore, you have the option to receive services offered by FEDEMAC EVENTS through alternative communication channels, such as by telephone.

The policy covers:

- 1. for employees of legal entities that receive FEDEMAC EVENTS services;
- 2. FEDEMAC EVENTS for job candidates;
- 3. to employees of various external service providers who provide or claim to provide services to FEDEMAC EVENTS;
- 4. to individuals, legal entities, representatives of state and local government institutions, non-governmental organizations, who contact FEDEMAC EVENTS by telephone, electronically or in writing regarding an issue of interest;
- 5. For visitors to the website and social network profiles managed by FEDEMAC EVENTS (hereinafter all together Data Subject or You).

#### I. Controller and its contact information

### II. Purposes of personal data processing, their scope and legal basis for processing

2.1. FEDEMAC EVENTS processes only the personal data necessary and to the extent required for achieving the previously specified purpose, namely:

- For making and announcing the decision, concluding the personnel selection - name, surname, contact information, date, fact and substance of the decision.

**Retention period:** 6 months from the date of decision in the specific selection process.

**Necessity of processing:** the provision and processing of personal data for personnel selection purposes are mandatory prerequisites for FEDEMAC EVENTS to evaluate applicants' compliance with position requirements. Failure to provide personal data will result in the applicant being unable to participate in the job selection procedure and will not be evaluated.

Provision of information to state administrative authorities, law enforcement authorities in the cases and to the extent specified in regulatory acts

The information containing personal data (name, surname, personal identification number, contact information, nature of the request, purpose and other information included in the request and which is issued when fulfilling it.

- Fulfillment legal of obligation example, (for regulatory governing acts administrative violations, criminal proceedings, which determine the obligation to provide information containing personal data);
- Pursuing our legitimate interests (for example, reporting a criminal offense against us).

**Retention period:** 5 years from the date of data processing.

**Necessity of processing:** the Data subject is not obliged to provide personal data to FEDEMAC EVENTS. Personal data is obtained and transferred to state administrative authorities, law enforcement authorities, courts in order to

implement the interests of FEDEMAC EVENTS, a third party or the public, including in compliance with the obligation to provide the information requested by the information requester as stipulated in the regulatory act regulating the relevant process.

Performing clerical functions (processing and responding to correspondence) Name, surname, personal identification number, address, e-mail address and other information contained in the received document and prepared response.

- Fulfillment of legal a obligation (for example, the obligation established in the General Data Protection Regulation (hereinafter GDPR) to exercise the rights of the Data subject, to prove fulfillment of such obligation);
- Implementation of our legitimate interests (for example, preservation of evidence to prove the legality of our actions with Your personal data, compliance with obligations set forth in regulatory acts and related aspects).

**Retention period:** 5 years from the date of response.

Necessity of processing: regulatory enactments (for example, the Law on the Legal Force of Documents, etc., the regulatory enactments regulating the relevant procedure or process) provide for the obligation to indicate the specified amount of personal data, so that FEDEMAC EVENTS' submission, request or complaint can be evaluated and an answer given in substance. Without complying with the requirements of the legal force of the document, commercial secrecy, without indicating the required amount of data, FEDEMAC EVENTS will not be able to consider and evaluate Your request on its merits.

Use of external services necessary for the performance of commercial activities

Identifying information of the signatory of the service provider, identifying and contact information of the contact person of the contract, information containing personal data contained in financial and payment data.

- Conclusion and execution of the contract;
- Implementation of our legitimate interests (receiving the service in accordance with the concluded contract; providing You with more convenient, more accessible services).

**Retention period:** until full fulfillment of contractual obligations and or until the statute of limitations for the purposes of exercising legal interests (commercial disputes - 3 years, data protection disputes - 5 years).

Necessity of processing: The Law on the Legal Force of Documents provides for the obligation to include the specified amount of personal data so that the document is legally binding for the contracting parties. The processing of contact information and contact data is necessary for the fulfillment of contractual obligations. In case of non-provision of personal data, contractual obligations cannot and will not be established. Failure to provide contact information, in case of changes, its current information can significantly limit the proper performance of contractual obligations.

### Verification of persons on sanctions lists

Name, surname, date of birth, personal identification number, nationality of the natural person and relationship with a legal entity, the fact, type, justification, period of the sanction imposed on the person, name of the country or organization that imposed the sanctions.

Fulfillment of legal obligations attributable to the administrator (Article 13.1 of the Law on International Sanctions and National Sanctions of the Republic of Latvia).

**Retention period:** 10 years from the date of data processing.

Necessity of processing: the Data subject is not obliged to provide personal data to FEDEMAC EVENTS. It obtains and processes personal data by itself, in compliance with the obligations set out in regulatory acts regarding the verification of persons on sanction lists. The processing of personal data is a mandatory prerequisite for FEDEMAC EVENTS to be able to fulfill its legal obligations and to make a decision on the establishment of contractual obligations. By not processing personal data, FEDEMAC EVENTS is not able to fulfill the obligation set forth in the regulatory acts and is not entitled to establish contractual obligations with the subject of sanctions or the legal entity whose true beneficiary is included in the sanctions lists.

# Representation of FEDEMAC EVENTS, ensuring interests in legal proceedings, organization of enforcement of court rulings

**Retention period:** 10 years from the date of entry into force of the court decision or its execution in the relevant dispute.

**Necessity of processing:** the Data subject is not obliged to provide personal data to FEDEMAC EVENTS. It obtains personal data and transfers it to court instances itself, in compliance with the obligations defined in regulatory acts regarding information containing personal data to be included in documents.

## Maintaining and improving the website

User's IP address; time of visit; pages visited and time spent there; browser type, operating system; web addresses from which the user has reached our website.

- Consent of the Data subject to the use of analytical cookies;
- legitimate interests includes the use of mandatory cookies, which are essential for the operation, convenience, and safety of using the website.

**Retention period:** according to the duration of each type of cookie specified in the section on the use of cookies in the privacy policy.

**Necessity of processing:** the website visitors are required to provide personal data to FEDEMAC EVENTS only if there is a desire to receive a personalized and relevant explanation based on the facts of the situation provided, as well as if there is a desire to use our website conveniently without re-entering personal data. information when placing an order, etc.

Necessity of processing: the procurement (price survey) regulations determine the amount of personal data that FEDEMAC EVENTS as the customer has the right to process, while the procurement (price survey) participants are obliged to provide. Failure to provide personal data or providing it in an incomplete amount prevents the possibility to participate in the procurement (price survey) procedure.

# Newsletter outbox and tracking

The e-mail address of the newsletter recipient, content and date of the newsletter, if and when an e-mail was opened by a Data subject, and which links in the e-mail were called up by Data subjects.

FEDEMAC EVENTS' legitimate interests (to inform existing and potential customers about news, promotions and new services).

**Retention period:** personal data is processed until the processing purpose is achieved, that is, until the news is sent.

Necessity of processing: the Data subject, if he wants to receive FEDEMAC EVENTS news, must provide FEDEMAC EVENTS personal data (e-mail, first name, last name, company, country). The processing of personal data is a mandatory prerequisite for receiving news. Without providing and processing personal data, FEDEMAC EVENTS will not be able to send and the Data subject will not be able to receive FEDEMAC EVENTS news. In addition, the email is initially required to accept the confirmation of receipt of news.

**Retention period:** 5 years from the date of detection or establishment of an incident or data protection violation.

Necessity of processing: the Data subject is not obliged to provide personal data to FEDEMAC EVENTS, except if the Data subject wants to report an incident or personal data protection violation to FEDEMAC EVENTS. In other cases, FEDEMAC EVENTS obtains personal data by itself, analyzing the information received from third parties about a possible incident or violation of personal data protection. The obligation to process the personal data of the Data subject affected by the incident is provided by the GDPR in order to investigate, prevent the violation and mitigate the adverse consequences for the Data subject related to the violation. By not processing personal data, FEDEMAC EVENTS will not be able to fulfill the obligation of the manager to investigate incidents and violations of personal data protection, including informing the Data subject if the violation poses a high risk to the rights and freedoms of the Data subject.

- 2.2. The aforementioned purposes of data processing are indicative and personal data may also be processed for purposes not directly mentioned, which are closely related to those indicated above and are necessary to fulfill the requirements of regulatory acts.
- 2.3. The specific amount of information depends on the specifics of the respective service provided, the purpose of data processing and the applicable laws and regulations that regulate the conditions of service provision.

#### III. Use of cookies

- 3.1.The FEDEMAC EVENTS website uses cookies. Cookies are small text files that are created and saved on Your device as an Internet user (computer, tablet, mobile phone, etc.) when visiting our website (<a href="https://www.fedemac.events/">https://www.fedemac.events/</a>). On each subsequent visit, cookies are sent back to the origin or another website that recognizes the cookie. Cookies "remember" basic information about Your website visit, thereby improving the ease of use of the website. You can get additional information about cookies, as well as how to manage or delete them, on the website www.aboutcookies.org.
- 3.2.FEDEMAC EVENTS uses cookies to: ensure efficient and secure website operation and improve it; improve its functionality and information availability; to obtain statistical information on website visitation in a certain period of time and visitors' interests in FEDEMAC EVENTS service types, etc.
- 3.3.All cookies that are not recognized as mandatory (technically necessary) can only be used with Your prior consent. We draw Your attention to the fact that mandatory cookies are a condition for using the website, so their use does not require consent. The website uses both mandatory

cookies, FEDEMAC EVENTS does not obtain consent for their operation, as well as analytical cookies:

<u>Necessary</u> (3) - Necessary cookies are used to make a website function properly and are generally not used for tracking. They are often used for user authentication, so that a website can remember who is logged in when the user navigates to different pages or refreshes the site. Necessary cookies can also be used to keep track of items in a shopping cart or to provide load balancing information.

- 3.4. When You visit our website for the first time in a pop-up window, You will be asked to confirm (button [confirm all]) the use of all cookies, as well as given the opportunity (button [customize]) to choose which other types of cookies You want to enable on Your device. You can express Your consent by ticking the fields opposite each type of cookie by pressing the pop-up cookie bar.
- 3.5. Third parties do not have access to the cookies used on the website.

### IV. Categories of recipients of personal data

- 4.1. In order to provide services appropriate to Your interests and needs, the conduct of FEDEMAC EVENTS business, the rights of FEDEMAC EVENTS, employees, and third parties, as well as to achieve the purposes of personal data processing, Your personal data may be received by third parties:
  - state administrative authorities (Data State Inspectorate, etc.) in case of receiving a complaint about the actions of FEDEMAC EVENTS, possible non-fulfillment of the requirements set forth in regulatory acts;
  - law enforcement and supervisory authorities in the cases specified in regulatory acts, for example, for the investigation and detection of criminal offences, administrative violations;
  - legal service providers, sworn auditors for providing legal assistance and audit services:
  - courts, if it is necessary to file a claim or legal proceedings have been initiated and You are one of the participants in the case;
  - debt recovery service provider, sworn bailiff in case of debt;
  - FEDEMAC EVENTS external service providers and processors who provide necessary services for FEDEMAC EVENTS' commercial activities or carry out data processing on our behalf to achieve processing purposes.

- 4.2. Processors involved in FEDEMAC EVENTS can process Your personal data only according to our instructions and may not use it for other purposes or transfer it to other persons without our consent. Such persons may be: database software maintainers; database administration service providers; websites, data center maintenance and cloud computing service providers, etc.
- 4.3. In each case, we submit to the processors only the amount of data that is necessary for the performance of a specific task or the provision of the specific services. In addition, they must ensure the protection of Your data in accordance with the requirements of applicable laws and the written agreement concluded with us, which, among other things, provides for the permanent deletion of any of Your data after the completion of the task given by us or the termination of cooperation.
- 4.4. FEDEMAC EVENTS does not intend to send Your personal data to third countries. If such a need arises, FEDEMAC EVENTS will transfer Your personal data outside the European Economic Area only if there is an appropriate legal basis for it, also ensuring a sufficient level of protection.
- 4.5. FEDEMAC EVENTS can obtain Your personal data from the following sources:
  - 4.5.1. law enforcement and supervisory authorities in cases specified in regulatory acts;
  - 4.5.2. correspondence submitters (natural persons, legal entities, state and local government institutions, non-governmental organizations) who submit information to FEDEMAC EVENTS for solving a relevant issue.
- 4.6. The aforementioned recipients and sources of personal data acquisition are indicative. Personal data may also be received by other recipients, and FEDEMAC EVENTS may obtain data from other sources, as long as this data processing is necessary to fulfill the requirements set forth in regulatory acts.

### V. Data subject rights

5.1. FEDEMAC EVENTS is open in its personal data processing activities and aims to promote awareness of data processing aspects. Thus, FEDEMAC EVENTS provides You with the implementation of the rights of Data subjects, providing a reasonable and friendly procedure for the realization of these rights. The extent of these rights and the procedure for realization depends on the relevant data processing activity and the personal data processed therein, namely:

5.2. The Data subject's right to receive a free copy of his/her personal data processed by FEDEMAC EVENTS may be limited if the request is unfounded or is submitted again for the same copy of data previously received. The receipt of the mentioned information may also be limited with the aim of preventing adverse effects on the rights and freedoms of other persons.

- 5.3. In order to protect the personal data of all our Data subjects from unlawful disclosure, we will need to verify Your identity upon receiving Your request to provide data or to exercise Your other rights. For this purpose, we may ask You to present an identity document, as well as, if the request refers to Your legal representative, a power of attorney or other document proving representation. If You do not confirm Your identity and/or representation, we will reject Your submitted request.
- 5.4. Upon receiving confirmation that FEDEMAC EVENTS is entitled to fulfill Your request, we undertake to provide You with information on the progress of Your request immediately, but no later than within one month from the receipt of Your request and the end of the verification procedure.
- 5.5. If Your request is submitted electronically, FEDEMAC EVENTS will also provide You with an answer electronically, except in cases where it will not be possible, for example, due to the large amount of information or if You ask for an answer in another way.
- 5.6. If we are forced to reject Your request due to the circumstances specified in the regulatory acts, we will inform You in writing about the rejection, justifying it accordingly.

### VI. Security of personal data

- 6.1. We use various security technologies and procedures to protect Your personal information from unlawful access, use or disclosure. Personal data is available only to those persons who need it for the performance of work duties and only to the extent necessary. Confidentiality agreements have been concluded with all persons who have access to personal data, as well as these persons are informed about the personal data protection rules and receive regular training.
- 6.2. Our chosen service providers are carefully selected, we require them to use appropriate means to protect the confidentiality of Your data and ensure the security of Your personal information. However, if information is transmitted via the Internet or mobile communications, its security cannot be fully guaranteed, so You must independently assess the risks related to the confidentiality of information and undertake them if You decide to transfer any information to us in the indicated ways.

### VII. Storage of personal data

- 7.1. FEDEMAC EVENTS, in accordance with the nomenclature of FEDEMAC EVENTS cases, stores personal data no longer than is necessary to achieve the purpose of personal data processing.
- 7.2. FEDEMAC EVENTS takes into account the following circumstances when determining the terms of personal data storage:
  - 7.2.1. whether the period of storage of personal data is determined or follows from the regulatory enactments of the Republic of Latvia and the European Union;
  - 7.2.2. for what period it is necessary to store the relevant personal data in order to ensure the realization and protection of the legitimate interests of FEDEMAC EVENTS or a third party;

- 7.2.3. until the consent given by the person to the processing of personal data has not been revoked and there is no other legal basis for data processing, for example, to fulfill the binding obligations of FEDEMAC EVENTS to prove the legality of its actions;
- 7.2.4. the moment of achieving the purpose of personal data processing.
- 7.3. By ensuring the provision of services offered by FEDEMAC EVENTS, FEDEMAC EVENTS complies with special regulatory acts, which determine its obligation to store individual data. For obtaining detailed information or in case of confusion, we invite You to contact FEDEMAC EVENTS using the contact information specified in point 1 of the policy.
- 7.4. After the end of the storage period, personal data will be permanently deleted, unless there is an obligation to store them in accordance with regulatory enactments.
- 7.5. Longer storage of Your personal data specified in this policy can only be implemented if:
  - 7.5.1. it is necessary for us to enforce our rights in relation to claims, claims or demands;
  - 7.5.2. there are reasonable suspicions of illegal activities that warrant an investigation;
  - 7.5.3. Your data is necessary for the proper handling of a dispute or complaint.
